## Terms and Condition for running the College Canteen during the Session 2023-2024

1. One contractor can file only one tender.
2. The successful tenderer has to deposit a Security Deposit of Rs.50000/- at the time of agreement and in case there is breach of agreement for running the canteen, the security deposit shall be forfeited.
3. The agreement shall be for a period of one year w.e.f. from taking over the possession i.e in the month of September 2023 upto 31<sup>st</sup> August, 2024.
4. The monthly rent will be Rs. 8000/- (excluding water and electricity charges). There will be enhancement of rent @ 10% per annum in case of extension. The rent should be deposited on or before 10<sup>th</sup> day of every month and after that Rs. 100/- shall be charged as late fee per day.
5. Advance payment of three months rent shall be deposited by the contractor to whom the tender is allotted
6. The tenderer has no right to sub-let, assign or authorize any other person to run the canteen.
7. The tenderer shall be responsible for the maintenance of canteen in an absolute clean and hygienic condition. The dustbins shall have to be placed/installed in and around the canteen.
8. The canteen shall remain open during the working hours (timings 9:00 a.m. to 3:00 p.m). During examination days , it can be extended upto 5.00 p.m.
9. The quality of the food items and their freshness shall be insured in the canteen by the contractor. The quality of food/services provided will be checked from time to time and if found unsatisfactory, the agreement would be cancelled without furnishing any advance notice. The college reserves the right to impose the fine if deemed necessary.
10. Illegal activities including consumption of drugs, alcohol, smoking, etc. shall invite cancellation of the contract and legal action will be taken.
11. For sale of any other item than the list of items approved, the tenderer will have to seek prior permission from the college authorities.
12. Items with MRP should be displayed on the canteen sale counter. The rate of the items sold will be according to the rate list approved by the college authorities. The rates of the items as mentioned in the tender should be at par with the market.
13. The contractor should have registered Good and Service Tax (GST/TIN)/Income Tax Return for atleast last 3 years in the name of the firm.
14. The canteen/college premises will not be used for residential purpose. No bathing or washing of clothes etc. will be allowed.
15. Music system is not allowed in the College canteen.
16. Approved Canteen contractor should start the canteen within seven days after approval of the tender failing which the tender shall be passed on to the next eligible contractor.
17. The conduct/character/antecedents and proper bonafide of the workers in the canteen shall be solely responsibility of the canteen contractor. However, the contractor should provide the necessary details of its employees to the college authorities. One female worker should be appointed by the contractor. The canteen contractor shall be held responsible for insurance of the canteen workers
18. Indian child labour Act shall be strictly observed by the contractor.

19. The contractor will install the fire-fighting equipment in the kitchen as per Fire Regulation and keep the premises harmless. Any damage arising on account of fire, theft or negligence on the part of the contractor or his/her staff shall be the responsibility of the bidder and he is responsible for any legal action under law.
20. On expiry of the said term or period of agreement or earlier termination thereof, the tender shall hand over peacefully the possession of the licensed premises to the college authorities in the same in which the premises now exist subject to normal wear and tear.
21. The contractor should have an experience of at least 3 years running a canteen in a college or any Govt. institution or any other establishment. The experience certificate should be issued by the head of institution which can be put to verification by any investigative agency.
22. The single use plastic shall not be allowed as per Govt. order F. No.B/17011/7/PWM/2022 dated 04-02-2022
23. The canteen shall be under CCTV surveillance.
24. In case of any food poisoning, the caterer will be held responsible and the college authority shall not be responsible for the same.
25. The violation of terms and condition shall call for cancellation of the allotment of the tender for running the canteen.
